#### AGE CRITERIA FOR APPLICATION OF ADMISSION :

## AGE CRITERIA FOR PRIMARY ONWARDS :

#### Grade 1: Age 6+

For admission in grade 1, S.KG. completion certificate is required.

#### ADMISSION CRITERIA :

Admission in our school is done through a general interaction with parents and students. The outcome of admission will be conveyed after that & the decision of management will be final and no further discussions will be entertained.

### CONFIRMATION OF ADMISSION:

On receipt of acceptance of admission, parents have to pay the fees within the stipulated date. The original documents should also be submitted.
